DECREE-LAW No. 291, Relative to the protection for the intellectual property of plant varities.

LAW 85 "FOREST LAW"

Article 54. In determined woods will be established areas dedicated to the preservation of forest genetic backgrounds.

The Ministry of Agriculture in coordination with the Ministry of Sciences, Technology and Environment dictates regulations for breeding, management and conservation of species, provenances or individuals included in the country's forest genetic resources genes.

RESOLUTION 111/1996 CITMA

- Article 12. In any case, once granted access and prior to its implementation will be agreed in writing and signed by the natural or legal persons concerned and the Authority in accordance with the provisions of Article 9, obligations, specifications limits, restrictions and conditions under which the mutual access takes place, in order to always guarantee:
 - a)appropriate environmentally uses to give to that resources;
 - b) the right to share, in a fair and equitable way the results and benefits arising from the commercial use or any kind of biodiversity resources of the country, including access to and transfer of technology in appropriate cases.

Any use intended to give to those resources that have not properly been agreed under the above provisions shall require the prior approval of the Chairman of the Environment Agency of the Ministry.

RESOLUTION 111/1996 CITMA CONT...

Article 13. If the claim to access to these resources were the purpose of conducting scientific research, all efforts will be made as soon as practicable, to be realized or settled in the country, for which previously established and guaranteed in the form caused by national stakeholders, the broadest possible participation of the Cuban part of the process of research and the use of its results.

Article 14. Once approved the application, with previous evaluation, and signed the agreement set forth in Article 12, the competent authorities will issue the corresponding environmental license, without which access to the requested resource is not allowed.
